GTC Digital Packages

1. Package booking

- 1.1. FWTM will provide, in accordance with the provisions of this agreement, the digital package arrangement booked by the exhibitor. The execution of TV recordings on the exhibitor's booth for The smarter E Expo TV (additional offer to package Digital Pro and Premium) is only guaranteed if the minimum quantity of 5 bookings is reached.

FWTM reserves the right to make changes to the digital package services, provided that the services have an equivalent value and changes are reasonable for the exhibitor.

2. Package prices, terms of payment

The price for the booked digital package will be invoiced to the exhibitor in Euro. This fee must be transferred to the bank account indicated on the invoice upon receipt of the invoice. Exhibitor status for the digital package in question will not exist until FWTM has received full payment of the fee. For packages with a minimum number of bookings, if this number is not reached, the amount will be credited and any payments refunded.

3. Cancellation of the event or parts of the event

The smarter E Europe Restart 2021 event consists of a face-to-face event and digital or hybrid elements. The services booked here are also available if the face-to-face event is cancelled. The bookings for The smarter E Expo TV (Digital Package Pro and Premium) at the exhibition floor will be moved to a TV studio. The optional bookability of TV recordings at the exhibitor's booth for the The smarter E Expo TV will be cancelled in this case. If a booking has already been made, it will be cancelled free of charge. If the digital and hybrid event elements are also canceled, FWTM will credit the exhibitor with the corresponding invoices and reimburse amounts already paid. The exhibitor is not entitled to any further claims in relation to the cancelled event.

4. Final provisions

- 4.1. FWTM is entitled to transfer all rights and obligations conferred by this agreement to third parties.
- 4.2. Amendments and additions to this agreement must be made in writing. This shall also apply to any waiver of the written form requirement.
- 4.3. In the event that one or more provisions contained in this agreement should be or become invalid or unenforceable, the agreement shall remain otherwise unaffected. The invalid or unenforceable provision shall be replaced by a valid and enforceable provision that, to the closest extent possible, reflects the economic purpose of the invalid or unenforceable provision. The same shall apply in the event of a gap in the agreement.
- 4.4. This agreement shall be governed by German law.
- 4.5. The courts of Freiburg i. Br., Germany, shall have jurisdiction for all controversies, disputes and claims arising from or in connection with this agreement. FWTM may furthermore bring an action against the exhibitor in the court with jurisdiction in the exhibitor's place of business. FWTM is alternatively entitled to seek a ruling from one or more arbitrators in accordance with the Arbitration Rules of the International Chamber of Commerce on all disputes and claims arising from or in connection with this agreement in accordance with these Arbitration Rules. The seat of the arbitration court shall be Freiburg i. Br., Germany. The arbitration proceedings shall be held in English.
